Have You Heard?

S pring was only an occasional hint in the slightly warmer damp air when I started this newsletter. October 2004 Contract Event

n a beautiful October day following our open house tours, an important event took place at the cottage. Our fifteenyear lease to operate the cottage was coming to an end, and it was time to sign a new contract.

Kermit Traska, current SPCC Board member and our former DNR liaison, had worked with Bruce Chevis of the Wisconsin Department of Natural Resources, the owners of

the cottage, to revise our original contract now that the rehabilitation of the cottage was accomplished. Their efforts culminated in a lease signing ceremony at the cottage on October 10.

The lease was signed by Bill Smith, Deputy Secretary of the DNR; Claire Barnett, Acting President of the SPCC; and Chris Wontor, Secretary of the SPCC. We felt honored to have the number two person in the DNR administration at our signing. Also attending from the DNR were Bill Morrissey, Parks and Recreation Bureau Director; Bruce Chevis, Concessions Program Manager; and Paul Zajackowski, Park Manager for Mirror Lake State Park. They all joined us for the annual fall color boat trip after the signing. The weather was beautiful and Waldo Peterson, SPCC Board member and

President of the Mirror Lake Association, had once again brought his pontoon boat and two others to make the tour possible. Cooling the Cottage

The spring workweek will bring an **L** exiting new development to the cottage! It came about this way ... The cottage, being a thick-walled stone building, is very comfortable year-round when one understands and follows the principles of using thermal mass. The stone causes the temperature inside the cottage to be slow to change, maintaining a fairly constant level of heat or coolness, since masonry buildings can be wonderfully cool in summer, too. But to work properly, the inhabitants need to understand *how* it works and *how* to maintain it, and we average about seven different guests over a two-week period of time. Our guests love the cottage and we want their experience to be everything that Mr. Wright and our Conservancy intended for them, but the summer season could sometimes become uncomfortable.

Opening up a house at night provides natural cooling of the structure, but not if the outside air contains high humidity, or the cottage has been open too long on a hot day. I experienced the result myself when I stayed at the cottage one hot August night almost two years ago, after the doors and windows had been open all afternoon for our monthly tour. I found that the cottage thermal mass still provided some cooling, but the atmosphere resembled a slightly damp, warm basement. We had provided fans in the summertime, and last year added a dehumidifier to the bathroom to help dry the extra moisture from use of the shower. But something more needed to be done.

Fortunately, when we replaced the boiler and heat exchanger a couple of years ago, the Facilities Committee, led by Vice President Bill Martinelli, had the foresight to install air conditioning coils within the furnace heat exchanger for future use. We began to discuss the possibility of air condition-

ing the cottage, resigned to the fact that with numerous summertime guests, it was impossible to keep a comfortable indoor environment at all times. Before anyone has time to imagine a huge ugly air conditioning unit either next to the cottage or squatting on the roof in plain sight, let me assure you that the Facilities Committee has taken every precaution. They looked for a short, compact condenser unit and then even took a box of similar proportions up to the top of the two-story roof. Then they walked around to see whether it was visible from most of the places from which one normally views the cottage. It wasn't, since the upper roof is recessed about a foot below the stone parapet.

So to our future summer guests, your experience will be enhanced without the distraction of unpleasant humidity. And to past summer guests, thank you for your expressions of enjoyment in the Guest Book, even though you may have been less than fully comfortable in the cottage during warm and humid weather.

The summer newsletter will provide pictures of the installation and reactions from our guests. It will also explain how the air conditioning works in a cottage heated with radiant floor heat.




