



## THE ENTRY SEQUENCE

or any architect, the way one reaches their building plays a major role in their design. At the Seth Peterson Cottage, your journey begins through a gate along Fern Dell Road. Back in 1959, the driveway was a shared entrance servicing multiple cottages. When Mirror Lake State Park acquired the property several years later, they installed a generic swing gate.

In 1996, Bill Martinelli designed a gate more consistent with Wright's aesthetic to replace the State Park gate. Bill's design included two sandstone pillars, supporting a pair of swinging gates with a sliding lock in the middle. The cost to construct two sandstone pillars and mount the steel gate was less than \$5,000, part of which was paid for by a grant from the Knowles-Nelson stewardship program.

#### FROM THE PRESIDENT

s I began thinking of what to write for my article for this newsletter, the word *longevity* came to mind. Longevity is a noun that means a long duration of individual life or length of life. It can also mean length of service, tenure, or seniority. While we generally think of longevity in terms of human life, we can also apply it to the life of the Seth Peterson Cottage. The life of the Cottage for more than two decades was dismal, as it was abandoned and left in ruin. With the 1991 creation of the public/private partnership between the Department of Natural Resources, owner of the Cottage, and the newly created Seth Peterson Cottage Conservancy (SPCC), the Cottage received a new life. The Conservancy, now in its third fifteen-year lease that goes through 2035, continues to oversee and care for the Cottage, making it available for the many overnight stays and Open House visitors each year.

Built of stone, wood and glass, the cottage has stood up well to the constant use of many visitors. Our Guest Comment Book provides evidence of the joy people experience during their stays. Part of longevity is not just surviving, but the quality of the experience our visitors have had during their stay in a work of art created by Frank Lloyd Wright.

Now let us apply longevity to our Board of Directors in terms of service and tenure. We have been blessed over the years to have many board members dedicated to overseeing the care and operation of the Cottage. Several of our current members were at the first meeting in 1989, and others have served for more than 25 years. At our recent Board of Directors meeting, we considered eliminating two board positions, going from 15 to 13 positions. It was pointed out that it's time for some "new blood" on the board as some of our current long-serving board members are approaching the end of their tenure. We will keep the board at 15 members and look for people to fill those positions. Recent board additions have included a business entrepreneur, a master cabinetmaker/educator, and a lawyer. Each brings with them a sincere interest in the work of Frank Lloyd Wright and a passion for the care and preservation of the Seth Peterson Cottage. Who will be the next SPCC board member?

We are thankful that the longevity of the Seth Peterson Cottage has been extended through the longevity and tireless work from the members of the Seth Peterson Cottage Conservancy Board of Directors.

### MIRROR LAKE STATE PARK REPORT— The "Other" Cabin at Mirror Lake State Park

irror Lake State Park features a unique, barrier-free log cabin nestled among the pines of the Cliffwood Campground. Built in the spring of 1991 and gifted to the Wisconsin Department of Natural Resources by the Telephone Pioneers of America - WI Chapter 4, this 700-square-foot cabin provides an accessible and scenic retreat. A screened-in porch offers beautiful views of Mirror Lake. Inside, the cabin includes a small kitchen, a bedroom with two single beds, a full-size sofa sleeper in the family room, and a bathroom with a roll-in shower. It accommodates up to six guests.

In 2018, the Friends of Mirror Lake State Park led a full renovation of the cabin. Upgrades included a completely remodeled bathroom, an enclosed front porch, and a new roof. Improvements were also made to the outdoor observation area, including a new bench, railings, and pathway repairs. This project was made possible through donations from the Friends of Mirror Lake State Park, a Knowles-Nelson Stewardship Grant, guest contributions, and support from local contractors.

Statewide, the Wisconsin State Parks Program offers 10 accessible cabins: eight larger cabins with full amenities and two smaller rustic cabins. The larger cabins are located at Buckhorn, Harrington Beach, High Cliff, Kohler-Andrae, Potawatomi, Richard Bong State Recreation Area, Mirror Lake, and Kettle Moraine State Forest–Southern Unit (Ottawa Lake).

These cabins are reserved exclusively for individuals with disabilities and their guests. Reservations for the following year open on January 10.


#### MIRROR LAKE ASSOCIATION REPORT

n Mirror Lake, I measure the seasons by when my pontoon boat goes in the water, and then about six months later, when my boat gets winterized and placed in storage. While autumn is my favorite season, I also realize that this means the end of my time on the water is near. Every week I drive from my home on the lake for 2-1/2 hours to the western suburbs of Chicago. The ride itself goes by quickly if I have something interesting to listen to. Another way that helps the time pass by is a long telephone conversation with a friend, like one I had last week.

My friend, Laura Colt, has become the newest member of the Seth Peterson Conservancy board of directors. She is a wonderful candidate to serve. Laura grew up on Mirror Lake where her immediate family members still reside. She is a successful attorney in Reedsburg. Most importantly, she is a loving spouse and mother. She has constantly displayed a strong loyalty to noble ideals. I am proud to call her a trusted friend. After exchanging hellos, we began to discuss her first meeting of the board. We spoke at length about the stated goals of the board. Then our discussion veered into another topic that really impressed her: the absolute dedication shown by the board. Dedication to the cottage, dedication to Frank Lloyd Wright, and dedication to the experience that others will enjoy as they spend time at the cottage.

As an ex-officio on the board member by virtue of my involvement in the Mirror Lake Association, I knew little of Wright's work. Certainly I knew of him and could identify his style of architecture, but that was about it. It was only after being involved with the board and witnessing the enthusiastic dedication of these fine people, that my eyes were opened - first to the beauty of the cottage, and then to the uniqueness of Wright's architecture. We appreciate your interest in the Seth Peterson Cottage and all that surrounds it. Now I am going back to my boat!

Fast forward almost 30 years later. Bill's design has withstood the test of time, and thanks to his continued efforts, we are now celebrating a newly paved parking lot and driveway. Because the cottage is occupied almost every night of the year and reservations are secured two years in advance, planning for this project began in 2022. Bill had to get quotes, block out a second week in April two years in advance, and then hope the weather cooperated.

Asphalt is a tricky material. Installation is always weather dependent, and the start of the installation season is as certain as knowing when spring will arrive. Once installed, the surface needed time to cure before anyone could drive on it. Thankfully the stars aligned, and we now have a more hospitable surface to drive on. This will also make it easier for snow-plowing when winter arrives, and for those with mobility impairments to access the property.

The cost to pave the parking lot and driveway was \$28,000. A last-minute grant from the Knowles-Nelson Foundation provided \$14,000. Maintaining the cottage and upgrading access like a paved driveway is the primary reason for creating The Seth Peterson Cottage Preservation Endowment Fund. Whether you have stayed at the cottage previously or just visited for a tour, please consider making a tax-deductible contribution to help ensure the cottage is around for future generations.

he Kristin Visser Historical Preservation Award Fund was established through a bequest from the Visser Family. 


